

| About My Fees | I will discuss and agree my fees with the parties involved before any mediation, which<br>must be paid in full in advance. My standard fees set out in the table below are based<br>on various factors, in particular, the amount in dispute (calculated as the value of the<br>claim and any counterclaim including interest and costs), how long the mediation is<br>likely to take, the preparation time and amount of pre-mediation contact with the<br>parties. |
